



**NOTICE OF RELATED CASES**

Plaintiff Gregory Holt a/k/a Abdul Maalik Muhammad seeks a preliminary injunction to reverse a retaliatory transfer aimed at mooted out his active litigation. Mr. Muhammad has five other active cases pending in this district asserting civil rights claims against the Arkansas Division of Correction (“ADC”) and its officers. Mr. Muhammad therefore provides notice of the following related cases involving the same or related parties:

1. *Holt v. Payne*, Case No. 4:22-cv-01132-KGB (E.D. Ark.) (“Jailhouse Lawyer case”). This case is pending before Chief Judge Baker. ADC Officers Dexter Payne, William Straughn, James Shipman, Maurice Culclager, Joseph Mahoney, and Karma Thorns are defendants.

2. *Holt v. Payne*, Case No. 5:19-cv-00081-BSM (E.D. Ark.), on remand from Case No. 22-01809 (8th Cir.) (“Jummah case”). This case is pending before Judge Miller. ADC Officers Dexter Payne, Dale Reed, Tommy Bourgeois, Andrea Culclager, and Joshua Mayfield are defendants.


3. *Holt v. Payne*, Case No. 4:22-cv-00553-JM-PSH (E.D. Ark.) (“Modesty case”).  
Post-judgment proceedings in this case are pending before Judge Harris. ADC Officers Dexter Payne and William Straughn are defendants.

4. *Holt v. Payne*, Case No. 4:24-cv-00074-BRW-ERE (E.D. Ark.) (“Ramadan case”).  
This case was pending before Judge Wilson and is now on appeal at Case No. 25-01507 (8th Cir.).  
ADC Officers Dexter Payne, William Straughn, James Shipman, and Muhammad Ameen are defendants.

5. *Holt v. Higgins*, Case No. 4:21-cv-01226-JM-JTK (E.D. Ark.) (“STTG case”).  
This case is pending before Judge Kearney. ADC Officer Jacob Higgins is the defendant.
